

The following outlines the terms and conditions in becoming a Member of the Australian Dance Council – Ausdance VIC.

Membership fees

Upon receipt of the Membership fee, you are registered as a Member of the Australian Dance Council – Ausdance VIC. Membership fees are payable in advance annually, renewing each year on the date you joined, with rates for the different types of membership approved by the Ausdance VIC Board.

Changing membership details

Only the named Member / organisation or person authorised in writing by the named Member may request a change in membership details.

Cancellation of membership

A Member may cancel their membership at any time by providing either verbal or written notification to the Australian Dance Council – Ausdance VIC.

Refund policy

Memberships are non-refundable however The Australian Dance Council – Ausdance VIC reserves the right to provide a refund in exceptional circumstances.

Security capabilities and policy for transmission of payment card details

All credit card transactions will be undertaken with best practice security. The Australian Dance Council – Ausdance VIC does not capture or store credit card information.

Currency

All memberships will be charged in Australian dollars and inclusive of GST.

Personal information use and disclosure

The Australian Dance Council – Ausdance VIC complies with all relevant Commonwealth and State legislation governing its operations. Your personal information will not be sold.

Lapsing of membership

Any Member whose fee is overdue for more than one (1) month will cease to be a member and will not be entitled to access any benefits and entitlements of membership.

Membership verification

All Members will create with a unique website log in. In circumstances where you are unable to remember your membership number or login, please contact the Membership Officer via membership.vic@ausdance.org.au

Member benefits access

All financial Members have access to The Australian Dance Council – Ausdance VIC’s member benefits. To access these, you will need to provide your first and last name to the partner and your unique log in. The partner may request to see identification. The partner may notify The Australian Dance Council – Ausdance VIC of your usage.

Only the named member may access member benefits and The Australian Dance Council – Ausdance VIC reserves the right to terminate a member without refund if they breach the terms of this agreement.

Child Safety Conduct

It is expected that all Ausdance VIC members will act in good faith and not undertake any actions that would bring Ausdance VIC into disrepute. Ausdance VIC members must abide by the current laws and regulations for the safety and wellbeing of children, particularly, though not exclusively, when working or volunteering in a dance or education environment. Ausdance VIC may request to review your Child Safety Policies at any time.

By agreeing to these terms and conditions, members agree to abide by the governments current child safety legislation.

Member termination

An active membership may be terminated without refund if any breach of these terms are identified and proven. We hold the right to remove any member from the organisation if they act in a manner which is deemed in breach of the law, abusive, bullying, racist, sexist, discriminatory, ageist, ablest toward any of our Board, staff, contractors, volunteers, members, stakeholders or other. (non-exhaustive list). This applies to any acts of public defamation, derogatory comments/actions or sharing of false information of The Australian Dance Council – Ausdance VIC.

If your membership is terminated for any reason, you may request a review by emailing victoria@ausdance.org.au with the subject title; Termination Review. Here you may outline your case. The ultimate decision on your review outcome will be at the discretion of The Australian Dance Council – Ausdance VIC.
