Membership Terms and Conditions

The following outlines the terms and conditions in becoming a Member of the Australian Dance Council – Ausdance VIC (Ausdance VIC).

Membership subscription fees

Upon receipt of the Membership subscription fee, you are registered as a Member of Ausdance VIC for a period of 12 months. Subscription fees are payable in advance, annually, with rates for the different types of membership approved by the Ausdance VIC Board. For new and existing members, membership is calculated from the date of joining.

Currency

Currency listed on the Ausdance VIC website and currency of transaction is in Australian dollars and inclusive of GST.

Security capabilities and policy for transmission of payment card details

All credit card transactions will be undertaken with best practice security. The Ausdance VIC website does not capture or store credit card information. Payments will be processed using Paypal, which is a secure payment gateway service provided by Paypal.com

Personal information use and disclosure

Ausdance VIC complies with all relevant Commonwealth and State legislation governing its operations. Your personal information will not be sold. You can view your personal details and edit your privacy settings by logging in to the membership portal on the Ausdance VIC website. For further details, please refer to our Privacy Policy available on the website.

Changing membership details

Only the named Member / organisation or person authorised in writing by the named Member, may request a change in membership details. Alternatively, membership details can be updated by logging in to the membership portal on the Ausdance VIC website.

Automatic renewal

Your payment method will automatically be charged, on the anniversary of your joining date, for each successive period (12 months) at the then-current subscription rate until you cancel your subscription, unless you cancel your membership 72 hours prior to the next billing cycle either in your Paypal account or the membership portal. An automatic renewal notice email will be sent to the named member 14-days prior to the payment method being charged.



Membership activation

Your membership will become active once confirmation of payment has been received. If you pay by credit card, your account will automatically be activated. If you pay by invoice, you need to forward receipt of payment to membership.vic@ausdance.org.au for your account to be activated.

Cancellation of membership

If you do not want to renew your membership, you can cancel your annual subscription at any time by logging in to the membership portal on the Ausdance VIC website and cancelling your subscription, provided both the person making the request and the membership concerned can be positively verified. You will retain access to your membership benefits until the end of the subscription period.

Refund policy

Memberships are non-refundable however Ausdance VIC reserves the right to provide a refund in exceptional circumstances.

Payment failure

Any Member whose fee is overdue for more than one (1) month will cease to be a member and will not be entitled to access any benefits and entitlements of membership.

Member benefits access

All Members have access to Ausdance VIC's member benefits as stated in the member benefits inclusions. To access these, you will need to meet the condition as outlined by the partner organisation. The partner may request to see proof of membership. The partner may notify Ausdance VIC of your usage. Only the named member may access member benefits and Ausdance VIC reserves the right to terminate a member without refund if they breach the terms of this agreement.

Voting rights

Under the Ausdance VIC Constitution, all financial members hold one right to vote in Board Elections and at the Annual General Meeting of Ausdance VIC.

Child safety and wellbeing commitment

It is expected that all Members who provide services for and/or work with children will act in good faith and abide by the current laws and regulations for the safety and wellbeing of children. This includes, but is not limited to, the 11 Child Safe Standards and the Child Employment Act.

Member termination

An active membership may be terminated without refund if any breach of these terms is identified and proven. We hold the right to remove any member from the organisation if they act in a manner which is deemed in breach of the law, abusive,



bullying, racist, sexist, discriminatory, ageist, ablest toward any of our Board, staff, contractors, volunteers, members, stakeholders or other (non-exhaustive list). This applies to any acts of public defamation, derogatory comments/actions or sharing of false information of Ausdance VIC. If your membership is terminated for any reason, you may request a review by emailing victoria@ausdance.org.au with the subject title; Termination Review. Here you may outline your case. The ultimate decision on your review outcome will be at the discretion of the Ausdance VIC board.
