At Ausdance Vic, we embraced the changing landscape in 2024, marking a year of renewal to strengthen our ability to foster connection through dance. I stepped into the role of Managing Director in July, following the invaluable leadership of Interim Executive Director Robbie Carmellotti, whose expertise guided the renewal process in the first half of the year. Our VET Industry Days remain a highlight, drawing sought-after teaching artists and receiving outstanding feedback from students. Meanwhile, our RTO team, led by Eilannin Harris-Black and Stephanie Clare-Cover, has streamlined systems to enhance efficiency, compliance, and customer service.

Finance and HR systems have also undergone improvements, ensuring a strong foundation for future growth. Complementing this, Marketing Manager Ava Kahveci has strengthened our branding and digital presence, most notably with our new website. Featuring a refreshed membership portal, course offering, and news section, our website, newsletters, and socials ensure we stay connected—supporting dance and the people who bring it to life.

CUA Training Package Updates

In 2024, we deepened our relationship with Service and Creative Skills Australia (SaCSA), the newly established Jobs and Skills Council for the arts and related sectors. Our input into training package updates has ensured the voice of the creative industries remains front and centre.

We contributed to the Unit Currency Audit Project's Initial Consultation Survey, advocating on behalf of the dance sector. Looking ahead, we'll continue this vital work in 2025, including early engagement on key initiatives such as the proposed cuts to Victorian Government Skills Training Funding and the development of a national VET workforce project.

Advocating for Safe Dance

We continued to build on the findings of the 2023 Victorian Dance Census by launching the Safe Dance Practice online course in mid-2024. This course—created in response to strong sector demand—offers professional development grounded in more than 30 years of research into injury prevention and dancer wellbeing by the Ausdance network.

Following a successful launch in Victoria, we plan to roll out the course nationally across the Ausdance network in 2025—turning research into real-world impact.





Advocacy

Supporting Independent Artists on the World Stage

Ausdance VIC was proud to support emerging choreographer and member Callum Mooney, who was selected to take part in the prestigious International Young Choreographers Project in Taiwan. With support from Ausdance VIC and the Chin Lin Foundation, Callum presented his new work 'equilibrium' and made lasting international connections.

We also supported First Nations artist Ngioka Bunda-Heath in her bid to present her work "Bridge" at the Indigenous World Dance Residency – Summer 2024 in Canada. These opportunities reflect our ongoing commitment to enabling Victorian dance artists to thrive globally.



Advocacy

Creative State Consultation

To support our submission to the Creative State 2025 consultation, we conducted an extensive engagement process, including surveys, focus groups, interviews with independent artists and organisations, and collaboration with our Board. Our submission addressed urgent sector challenges such as limited access to space, evolving audience behaviours, cost-of-living pressures, and insecure employment. We advocated for a whole-of-government approach to creative sector investment, focusing on five key priorities:

- Supporting Independent Dance Artists
- Strengthening Dance Education and Training
- Investing in First Nations Dance
- Fostering Innovation and Creativity
- Diversifying Funding Sources

Ausdance VIC will continue to engage with the Creative State process in 2025 to ensure the dance sector's voice is heard.

Advisory Services

As the funded service organisation for dance in Victoria, providing sector support is at the heart of what we do. In 2024, we delivered more than 40 tailored advisory sessions to independent artists, students, and organisations. Topics ranged from insurance and child safety compliance to workforce development, funding opportunities, and accredited training updates. Support was available via phone, email, and in person.

Evolving Our Membership Model for a Diverse Dance Community

In 2024, we undertook a major review of the Ausdance VIC membership model to better reflect the evolving needs of our community. After a year of planning, listening, and consulting, we launched a new membership program with flexible levels and refreshed benefits tailored to a diverse sector.

New Membership Levels

A free membership for dance lovers, supporters, and advocates.

For students in secondary or tertiary dance education.

For freelance dancers, choreographers, and teachers.

For studios, community groups, and schools.

MED-LRG ORGANISATION

For institutions or organisations with a turnover over \$250,000.

Digital Transformation for Better Service

Our membership management portal received a major upgrade as part of our broader digital transformation strategy. The new system includes improved functionality such as easier password resets, billing updates, membership switching, and enhanced privacy controls.

To ensure a smooth transition, all members received a complimentary sixweek extension on their membership.

Adjusting Fees to Sustain Our Work

We understand that affordability matters. That's why we froze membership fees during the COVID-19 period and kept them low over the past four years. However, with rising costs and a growing demand for services, we've made the considered decision to return fees to pre-pandemic levels in early 2025.

While we anticipate a short-term dip in membership as our community adjusts, we're confident that the improved program will demonstrate its value. We have strong retention strategies in place to support members through the transition.

Showcasing Membership Impact

Ausdance VIC member Jennifer Fleenor-O'Brien, founder of UNLID Dance Theatre, was the only Australian artist featured at the prestigious Singapore International Dance Festival and Conference (SIDFC), presented by World Dance Alliance. This opportunity was made possible through affiliate access granted to Ausdance VIC members.

"It was an incredible honour. The festival's focus on both academia and performance made it a brilliant opportunity for meaningful discussions about the future of dance research. SIDFC allowed us to engage in insightful discussions within the World Dance Alliance's vibrant community."

Her experience underscores the unique value of membership and our role in championing artists on the world stage.

Reaffirming Our Leadership in Dance Education

In 2024, Ausdance VIC reaffirmed its position as a leader in dance education and training, accounting for nearly half of all VET Dance enrolments in Victoria. This milestone underscores our ongoing commitment to delivering high-quality vocational education pathways for emerging dancers and teachers across the state.

Launch of a New Learning Management System

A key highlight of the year was the successful launch of our new Learning Management System (LMS), developed to enhance the learning experience for both students and trainers. Feedback has been overwhelmingly positive: students praised the platform's user-friendly interface, while trainers welcomed its streamlined course delivery and assessment tools. We remain dedicated to refining and improving the LMS to meet the evolving needs of our learners.

Expanding Pathways for Tertiary and Creative Industry Students

Another significant development in 2024 was the expansion of our accredited course offerings. We added the Certificate IV in Dance and the Certificate IV in Musical Theatre to our scope, offering tertiary students more options for advanced performance training.

In addition, the introduction of the Certificate II in Creative Industries—set to launch in July 2025—will provide students with essential skills for behind-thescenes roles in the performing arts. This broadening of scope reflects our active role in addressing Australia's creative industry skills shortage, both on and off the stage.

Extending Our Reach to Regional Victoria

To increase access and equity, we delivered a regional VET Dance intake in Cann River, a remote community located five hours from Melbourne. This initiative demonstrates our ongoing commitment to making high-quality dance education accessible to students across Victoria, regardless of geography.

2024 was a standout year for Ausdance VIC's programs, with thousands of students and educators engaging in high-quality, curriculum-aligned dance education across Victoria. With momentum on our side, we're excited to build on this success in 2025.

Blue Sky Dance

Blue Sky Dance continued to bring inspiring, high-quality dance experiences to regional and rural communities, reaching 15 schools and 550 students. By blending live-streamed and in-person workshops, we ensured accessibility while delivering content aligned with the Victorian Curriculum.

Teachers also participated in tailored professional development, helping to embed dance more deeply in local school communities. Valuable feedback gathered in Term 4 is already guiding improvements for the 2025 program rollout.



LIFT: Elite Dancer Enrichment & Industry Days

Now in its third year, the LIFT program provided close to 2,000 students with real-world, industry-connected experiences in 2024. Students participated in workshops, mock auditions, and exam preparation led by professional artists and educators.

Funded by the Department of Education, this program continues to support the next generation of dancers by building their confidence, skills, and industry connections.



Inspire: Professional Development for Educators

The Inspire program brought together 61 teachers from 40 schools to participate in workshops led by First Nations dance artists. Funded by the Department of Education and delivered in partnership with Dancehouse, the program invited educators to explore their own movement practice while learning to introduce contemporary First Nations dance into the classroom.

Participants received access to two curriculum-aligned resources and could choose between in-person, online, or on-demand video delivery, ensuring the program remained accessible regardless of school location or budget.

We're thrilled to announce that Inspire will return in 2025 with two new First Nations choreographers joining the program to share their unique perspectives and knowledge.

Teacher Connection Event

In October 2024, we hosted our inaugural Teacher Connection Event in partnership with Dancehouse—a relaxed and inspiring evening that brought together school teachers and professional dance companies.

The event created space for educators to network, share ideas, and strengthen relationships across the sector, ultimately benefiting both students and teachers. Following its success, we're planning to return with this initiative in 2025.

Activate! Education Resource

Our popular Activate! resource underwent a major transformation in 2024, thanks to direct feedback from teachers across the state. This included:

- Redesigning the flash card series
- Creating a full video library of activity demonstrations
- Aligning all content to the updated Victorian Curriculum 2.0
- Launching a new user-friendly home for the resource on our website

Funded by the Department of Education, the resource is set to reach over 1,400 Victorian state schools in Term 2, 2025—supporting more than 330,000 students and 49,000 teachers to incorporate dance into their classrooms.

In addition to the resource itself, we collaborated with the Department to develop a 'Guide to Dance in the Curriculum', helping teachers create curriculum-aligned lesson plans using Activate!. We've also secured an agreement to make the resource publicly available via our website—ensuring equitable access for all Victorian schools.

Refining for Real Engagement

In 2024, we sharpened our focus on quality over quantity by prioritising meaningful engagement with our audiences. While we've built a large audience over the years, our analysis revealed that many were passive or no longer engaged—negatively impacting reach and performance. Over the past two years, we've worked strategically to better understand our audience across each channel, identify what resonates with them, and refine our content accordingly.

Our approach centred on three key actions:

- Removing disengaged subscribers and followers to improve deliverability and relevance
- Trialing and prioritising high-performing content tailored to each platform
- Refining our reporting methods to better understand and measure effectiveness

Digital Transformation

Our most significant marketing initiative in 2024 was the redevelopment of the Ausdance VIC website—a project aimed at transforming how we connect with members, stakeholders, and new audiences. Key features of the redevelopment include:

- A refreshed site structure and navigation to improve user experience
- Updated design and content, meeting higher accessibility standards
- e-Commerce functionality to better support revenue-generating activities
- A new membership portal designed to improve member services
- Integration of a CRM and marketing automation tool to streamline communication with members, partners, and prospective supporters

Initially scoped as a six-month project, we extended the timeline after trialling and assessing an initial CRM option. This allowed us to pivot and select a more suitable, long-term solution that better aligned with our goals.

The new website is on track to launch in February 2025, and we're proud of the cost-effective approach we've taken. By negotiating a low-cost development arrangement and selecting affordable, well-supported applications that natively integrate with our systems, we've created a sustainable platform for the future.

Crucially, we've diverted funds previously used to maintain an outdated and high-maintenance system into this new infrastructure. The result is a user-friendly, integrated digital ecosystem that we believe will serve the organisation's needs over the next four years—supporting growth, communication, and impact at every level.



Looking Ahead

A Bold Vision for Impact

As we step into 2025, Ausdance VIC is building on a renewed foundation with clarity of purpose and an eye to the future. This is a year of strategic evolution—where the work of 2024 begins to bear fruit.

We are deep into the development of our 2026–2029 Strategic Plan, a blueprint that will align our values with a bold vision for impact. With a new fundraising subcommittee in place, we are diversifying revenue streams to strengthen long-term sustainability. Our digital transformation continues to deliver results, from a new website to improved member engagement and streamlined operations.

In education, we're expanding nationally with the Safe Dance Practice course and launching new accredited offerings to support a broader range of creative careers. Our programming continues to centre access, equity, and excellence—reaching more students and teachers across the state than ever before. With Inspire, Activate!, and LIFT all set to return in 2025, our commitment to curriculum-aligned, inclusive dance education is stronger than ever.

Through partnerships and advocacy, we'll continue to support artists, amplify voices, and ensure that dance remains a vital, visible part of Victorian life.
